For **ADULT REFERRALS** to County Mental Health Plan please follow the workflow below:

The County of San Diego has four Behavioral Health Centers (BHC) that provide services to clients within their service area. Service areas are divided by zip code. Identify which BHC provides services for client's residence. If a client is experiencing homelessness, select BHC closest to client's preferred location send to any Fax referral to respective clinic. Screening Team is available for questions and support and will confirm receipt of referral by phone no later than 2 business days of receipt. The four referral sites are located below:
